

The Central Park Papers - Contract

David Wise agrees to sell "The Papers" (a copy of the Central Park Papers) to the undersigned for a fee of \$60. "We" (the undersigned) agree to the following:

Confidentiality

- **WE WILL KEEP CONFIDENTIAL THE PAPERS AND ANYTHING WE DISCOVER BASED ON THE INFORMATION CONTAINED WITHIN THE PAPERS FOR TEN YEARS AFTER THE DATE DAVID WISE SIGNS THIS CONTRACT.** We will not discuss The Papers with anyone except David Wise and the other undersigned persons of only this contract (provided it has been signed by David Wise). We will not show The Papers to anyone. We will keep The Papers in such a manner as to prevent anyone else from discovering or reading them.
- We are bound by our honor and are legally bound to not share The Papers with anyone. **WE FURTHER AGREE THAT IF WE SHARE THE PAPERS, REPRODUCE THE PAPERS IN ANY MANNER, OR DISCUSS THE PAPERS OR WHAT WE DISCOVER BASED ON THE INFORMATION CONTAINED WITHIN THE PAPERS WITH ANYONE ELSE BEFORE TEN YEARS AFTER THE DATE OF THIS CONTRACT, WE WILL BE LIABLE TO DAVID WISE FOR THE FULL AMOUNT OF DAMAGES FOUND AND BE RESPONSIBLE FOR ALL COURT, ATTORNEY, AND RELATED EXPENSES.**
- Any information based on The Papers provided to us by David Wise is subject to the same confidentiality limitations as The Papers themselves.

Liability

- We purchase The Papers at our own risk. David Wise does not guarantee the accuracy or authenticity of The Papers. They are provided for entertainment purposes only.
- We agree we are solely responsible for our actions after receiving The Papers and we will not hold David Wise liable for any injury or damage we sustain in relation to The Papers. We agree to conduct ourselves in a manner that is legal and that is not in violation of the rules of Central Park.
- Any damages for which David Wise will be liable will be limited to the price paid for The Papers.
- Any actions or proceedings arising from this contract will be brought in state or federal courts located in New York County, New York, and the undersigned hereby consent to jurisdiction and venue therein.

Consulting David Wise

- It is at David Wise's discretion whether, when, and how he will answer questions. David Wise may, at any time, cease answering questions.
